**The Dupont Park Civic Association supports Bill 17-0915, the “Downtown Anacostia and Pennsylvania Avenue Eminent Domain Authorization Act of 2008” submitted to the Committee on Economic Development on July 15, 2008 by Councilmember Marion Barry and Co-Sponsored by Council members Yvette Alexander and Jim Graham, Councilmember At-Large Kwame R. Brown, and Council Chair Vincent C. Gray.**

**The Dupont Park Civic Association (DPCA) is located in Ward 7 and Pennsylvania and Minnesota Avenue, SE are within our boundaries. For many years, unsuccessfully, residents of DPCA and Ward 7 have sought redevelopment projects in this area to include the projects and activities listed on the attachment to this letter. We are excited about the prospect of change.**

**I would like to note that Pennsylvania Avenue is:**

- called "America's Main Street"**
- an important commuter route**
- part of the National Highway System**
- one of the earliest streets constructed in the federal city**

**Yet, when you cross the Sousa Bridge “America’s Main Street” changes to an area afflicted with buildings and improvements that are obsolete, dilapidated, and deteriorated; it becomes a “blight” to the residents, to the community and to the city. The side of Pennsylvania Avenue across the Sousa Bridge deserves modernization via economic development projects similar to those occurring all around the city.**

**DPCA views Bill 17-0915 as the catalyst to the transformation of not only the 2300 Block of Pennsylvania, but the remaining blocks on both sides of the street to Southern Avenue, specifically Blocks 2300 -2600 and 3200-3300. It is time for this**

great city to direct focus, attention, resources, planning, action, etc. to reinvigorate the stalled development projects identified on the attachment. We strongly believe that redeveloping the Pennsylvania Avenue-Minnesota Avenue, S.E. Intersection Area will improve the safety and quality of life in this area and attract the type of businesses desired by the residents.

DPCA is interested in meeting with you, Council Chair Vincent C. Gray, Councilmember Yvette Alexander, and other appropriate District Officials to discuss the city's plans regarding the Pennsylvania Avenue, SE, Corridor Land Development Project.
